In line with Corporate Disclosure requirements, we wish to inform you that NTPC Green Energy Limited has decided to issue unsecured non-convertible debentures of Rs. 1,500 crore on 11.11.2025, through private placement at a coupon of 7.01 % p.a. for a tenor of 10 years 1 day, maturing on 12.11.2035, under the board resolution dated 29.04.2025.

This is the first issue of debentures under the above-mentioned approval.

Proceeds shall be utilized for, inter alia, financing capital expenditure, including refinancing and recoupment of capital expenditure already incurred by the Company, as well as for extending such financing for capital expenditure to its subsidiaries and joint ventures through inter-corporate loans, and for other general corporate purposes.
